**Landlord v Tenant dispute** - retention of deposit monies - settlement reached within 1 hour.

**Employee v Employer dispute** - accusations of theft & counteraccusations of disability discrimination. Employee certified absent for several months. Settlement reached during the mediation.

**Landlord v Tenant** - damage to property & deposit money retention - settlement reached within 1 hour.

**Construction firm v Letting Agent** – contractual dispute – settlement reached within 2 hours.

**Tenant v Housing Association** – housing disrepair dispute – mediation involving representative solicitors. Within 1.5 hours & via telephone parties had reached agreement on a settlement for costs and damages.

**Employee v Employee dispute** – accusations of bullying and aggression. Employee absent for several months. National employer sought mediation. Settlement terms & plan of action agreed during the mediation.

**Parent v Local Authority** – SEND mediation – dispute concerned placement and the nominated school. A solution was agreed to gather further evidence and submit the matter back to panel for consideration.

**Parent v Local Authority** – SEND mediation – dispute concerned placement. A solution was agreed to gather further evidence and submit the matter back to panel for consideration.

**Multi-employee dispute** – workplace dispute – various accusations of harassment, bullying, discrimination. A broad solution was agreed between the 6 employees involved and approved by the employer.

**Ltd Company v Ltd Company** – large commercial debt dispute – generated by one of our Chamber of Commerce mediation schemes. An international company had received judgment against a local company. Within 3 hours the parties were able to agree a repayment process & insolvency was avoided.

**Parent v Local Authority** – SEND Mediation – a refusal to assess for an EHCP. Within 1.5 hours the parties had agreed a process to gather some additional information before resubmitting the matter to panel for reassessment.

**Tenant v Housing Association** – housing disrepair dispute – mediation involving representative solicitors. Within 1.5 hours & via telephone parties had reached agreement on a settlement for costs and damages.
